Pursuant to subdivision 617.7(a) of the SEQRA regulations, the Commission has determined that the proposed action may include the potential for at least one significant adverse environmental impact potentially occurring due to:

- A potential substantial change in the use or intensity of use of land including agricultural, open space or recreational resources, or in the capacity to support existing uses and
- The potential creation of a material conflict with a community's current plans or goals as officially approved or adopted.

Change in Use or Intensity of Use of Land: Land use development in the Central Pine Barrens may be directly and irreversibly impacted by potential additional constraints on locations in which actual construction and disturbance can occur. This may result in more intensive development on portions of project sites than that which previously occurred due to proposed guidance which provides greater specificity than currently in regard to areas which should be protected as open space or avoided during development. The action may alter the pattern and design of future development within the Compatible Growth Area somewhat from what was contemplated under the original 1995-era land use development requirements in the Central Pine Barrens Comprehensive Land Use Plan. As such, the action may potentially result in changes in the patterns of development use in the future of existing undeveloped land. This may include farm land and future open space configurations. Accordingly, future land use development occurring in the Central Pine Barrens pursuant to the proposed amendments may also result in changes to existing transportation systems from what would have occurred if the proposed amendment action were not undertaken.

Material Conflict with a Community's Current Plans or Goals: The proposed action has the potential to conflict with existing hamlet, neighborhood or similar plans within those portions of the towns and villages which comprise the Compatible Growth Area of the Central Pine Barrens, and which are subject to future development, and may also potentially conflict with plans undertaken at the county level.

Impact on Critical Environmental Areas (CEAs): The Central Pine Barrens is a CEA and contains within it multiple other Suffolk County and Town-designated CEAs. However, although the proposed amendments contemplated under the action would be implemented in regard to developable land within the Compatible Growth Area portions of these CEAs, overall the effects are considered to be minor or beneficial because the proposed action is designed to provide increased environmental protection to the resources for which these CEAs were created.
