| April 15, 2015 (Commission Meeting) | <i>(if 3 Towns respond in 27 days or less and all assent to Commission as Lead Agency)</i> Commission declares Lead Agency, issues SEQRA Positive Declaration (Type I action) and Intent to Conduct Public Scoping for the preparation of a Supplement to the existing CLUP GEIS |
| April 16, 2015 | Commission staff sends notice of Positive Declaration to Environmental Notice Bulletin for publication |
| May 20, 2015 (Commission Meeting) | Commission issues Draft SEQRA Scoping Document with 30-day comment period |
| May 21, 2015 – May, 22, 2015 | Commission staff circulates Draft SEQRA Scoping Document and current set of CLUP Amendments, for 30-day comment period, to interested parties |
| June 21 – July 14, 2015 | Commission staff receives and reviews comments on Draft Scope and prepares Final SEQRA Scope for Supplement to the existing CLUP GEIS (Supplemental Draft GEIS) |
| July 15, 2015 (Commission Meeting) | Commission issues Final SEQRA Scoping Document and Commences Preparation of Supplemental Draft GEIS |
| July 16, 2015 – September 1, 2015 | Commission staff prepares Supplemental Draft GEIS |
| September 2, 2015 | Commission staff submits Draft Supplemental GEIS to Commission members |
| September 16, 2015 (Commission Meeting) | Commission Adopts Resolution Accepting Supplemental Draft GEIS and Adopts Resolution to Schedule series of combined SEQRA and traditional Public Hearings on the Supplemental Draft GEIS and CLUP Amendments |
| September 17, 2015 | Commission staff sends notice of public hearing to Newsday for publication in legal ads and posts on Commission website. Commission staff sends notice of Acceptance of Supplemental Draft DGEIS and Notice of Public Hearing to Environmental Notice Bulletin for publication |

Dates and locations are tentative and subject to availability of public spaces, such as Town Halls)</i> <i>(Close hearing but consider accepting written comments for 10 additional days until November 30, 2015)</i> |
| November 30, 2015 | Deadline for additional written public comments on proposed CLUP Amendments |
| December 1, 2015 – December 16, 2015 <i>(Commission Meeting)</i> | Preliminary review of public comments received |
| December 1, 2015 – January 4, 2016 | Commission staff compiles and reviews public comments, prepares responsiveness summary and submits all to Commission |
| January 20, 2016 <i>(Commission Meeting)</i> | Commission reviews public comments and responsiveness summary. Commission advises staff in regard to any further revisions to proposed CLUP amendments. |
| January 21, 2016 – February 29, 2016 | Commission staff prepares Supplemental Final GEIS and completes revisions to proposed CLUP amendments |
| March 1, 2016 | Commission staff submits Supplemental Final GEIS and revised CLUP amendments to Commission |
| March 16, 2016 <i>(Commission Meeting)</i> | Commission adopts Resolution accepting Supplemental Final GEIS and schedules public vote on Amendments (30 days prior notice required) |
| March 17, 2016 | Legal Notice regarding CLUP Amendment vote sent to Newsday for publication on March 18, 2016 and posted on Commission website |
| March 17, 2016 | Commission staff sends notice of Acceptance of Supplemental Final GEIS to Environmental Notice Bulletin for publication |
| March 17, 2016 – March 22, 2016 | Commission staff circulate notices of Acceptance of Supplemental Final GEIS, along with copies of adopted Supplemental Final GEIS and revised set of CLUP Amendments, to interested parties |
