ICS-400	Advanced ICS	Course Description: Course is designed to enable personnel to operate efficiently in the advanced application of the Incident Command System in a complex incident environment. Topics include: fundamentals review for command and general staff, major and/or complex incident/event management, Area Command, and multiagency coordination. National Incident Management System (NIMS) compliant.	Required ICS-300	10/24 – 10/25
G-191	Incident Command System/Emergency Operations Center Interface	This course reviews ICS and EOC responsibilities and functions and depends heavily on exercises and group discussions to formulate the interface. The course provides an opportunity for participants to begin developing an interface between an Incident Management Team and EOC personnel.	None	10/24
UAS-107 Prep	Unmanned Aircraft Systems FAA Prep Course	This course will help first responders to prepare for the FAA Part 107 Exam required when flying UAS (Drones) for non-recreational purposes. The course along with an additional 10-15 hours of self-study will prepare the student for successful completion of the FAA Part 107 exam. Students are encouraged to schedule their exam as soon possible upon completion of this course.	None	10/22 – 10/23
