FI-210	RX-310
Wildland Fire Origin & Cause Determination	Introduction to Fire Effects
The primary purpose of this course is to provide a consistent knowledge and skill base for the Wildland Fire Investigator (INVF). The concepts taught in this course will help an INVF perform at an acceptable level on a national basis without regard to geographic boundaries.	This course is designed to provide students with the skills necessary to recognize and communicate the relationships between basic fire regimes and fire effects, the effects of fire treatments on fire effects, and to manipulate fire treatments to achieve desired fire effects.
Prerequisite(s): Completion of pre-selection assessment and pre-work Fee: \$450	Prerequisite(s): None Fee: \$400
S-130/190	S-131
Firefighting Training/Intro to Wildland Fire Behavior (Field Days Only)	Firefighter Type 1
This course is for individuals who have taken S-130/190 online. Students must submit proof upon arrival to the academy that they have completed the online portion of this class. Please visit the Wildland Fire Learning Portal at wildlandfirelearningportal.net/ to complete the online requirements for S-130, S-190, and L-180 (On Demand Self-Enroll Courses).	This course is designed to meet the training needs of the Firefighter Type 1 (FFT1) and/or Incident Commander Type 5 (ICT5). It contains class discussion and several tactical decision games designed to facilitate learning the objectives. Topics include operational leadership, communications, LCES, and tactical decision-making.
Prerequisite(s): S-130/190, L-180 Online course Fee: \$200	Prerequisite(s): Qualified as a Firefighter Type 2 (FFT2) Fee: \$100
S-200	S-215
Initial Attack Incident Commander	Fire Operations in the Wildland Urban Interface
This course is designed to meet the training needs of the Incident Commander Type 4 (ICT4). It is presented in a discussion/exercise format. The six instructional units include: Foundation Skills, Intelligence Gathering and Documentation, Size Up the Incident, Develop a Plan of Action, Post-fire Activities, Evaluating Incident Objectives and Manage the Incident. Evaluation of the student is by unit tests and performance-based evaluations.	This is an instructor-led course intended to be presented at the local level. Instructional units include firefighter safety in the interface, managing human factors in the interface, pre-incident planning, size up and initial strategy, structure triage, structure protection overview, tactics in the interface, tactical operations and resource use in the interface, action assessment, plan update, and after action review.
Prerequisites Qualified as any Single Resource Boss. Satisfactory completion of pre-course work. Fee: \$200	Prerequisite: Qualified as a Firefighter Type 1 (FFT1) Fee: \$280

S-219	S-230
Firing Operations	Crew Boss (Single Resource)
Identify the roles/responsibilities of the Firing Boss (FIRB) for planning, execution, safety, coordination, and evaluation of ignition operations on a wildland or prescribed fire. Describe/demonstrate the applications of various firing devices. Students will prepare a firing plan and briefing that discusses fire behavior, firing techniques, resource requirements, coordination, safety, and risk factors to meet specific objectives.	Course provides students with the knowledge and skills to perform the duties of the Crew Boss (CRWB) position (NWCG Incident Position Standards for Crew Boss, PMS-350-98). Topics include travel and check-in in, briefings, assigning tasks and assessing crew performance, implementing fire line duties, mop-up, firing operations, using aerial resources, medical emergencies, and wildland urban interface.
Prerequisite(s): Qualified as a FFT2 Fee: \$280	Prerequisite(s): (FFT1) and successful completion of Intermediate Wildland Fire Behavior (S-290) Fee: \$200
S-290	S-359
Anticipating Wildland Fire Behavior 2-Day Blended Course	Medical Unit Leader
New two-day blended S-290 course includes approximately 16 hours of online course work and two days in-person to review and complete exercises. Course objectives include: characteristics of fuels, weather, and topography that influence wildland fire behavior; interaction of fuels, weather, and topography on wildland fire behavior, fireline tactics, and safety and causes of extreme fire behavior conditions (long range spotting, crowning, and fire whirls) that develop due to weather, fuels, and/or topography. Interpret, communicate, apply, & document wildland fire behavior and weather information.	In the online portion of the course, students explore the knowledge and concepts required to meet the responsibilities of the Medical Unit Leader (MEDL), from mobilization to various incident changes. The ILT portion of the course provides scenario-based activities that allow participants to apply the knowledge and concepts required to meet the responsibilities as identified in the National Wildfire Coordinating Group (NWCG) Incident Position Standards for the MEDL.
Prerequisite(s): Completion of S-190 Introduction to Wildland Fire Behavior. Satisfactory completion of online course work through the Wildland Fire Learning Portal (approximately 27 hours). You must setup a WFLP account or have an active account. Fee: \$200	Prerequisites: Current certification as an Emergency Medical Technician (EMT) or equivalent. Fee: \$280
THIS CLASS WILL BE HELD IN NEW JERSEY RX-410	
Smoke Management Techniques	
This course leads students through the ecological and historical role of fire, characteristics of smoke and the health, safety and visibility impacts of smoke. Other topics include public relations, legal requirements, meteorology, fuel consumption, smoke production dispersion modeling, and operational smoke management strategies. This course is designed to be interactive in nature. It contains a panel discussion, several exercises designed to facilitate group and class participation and case studies from a variety of fuel types and political challenges. The pre-course work assignment is designed to familiarize students with the NWCG Smoke Management Guide for Prescribed Fire, PMS 420-2 , and air quality regulations that impact prescribed fire programs.	
Prerequisites Students should have a background in prescribed fire planning, implementing, monitoring, permitting or smoke/air regulating and satisfactory completion of pre-course work. Fee: \$450 Location: Burlington County Emergency Services Training Center - 53 Academy Dr, Westampton, NJ 08060

DECEMBER COURSE DESCRIPTIONS

RT-130	S-112
Wildland Fire Safety Training Annual Refresher (WFSTAR)	Introduction to Chainsaw Operations (Blended)
Wildland Fire Safety Training Annual Refresher (WFSTAR) is to focus line-going personnel on operations and decision-making issues related to fireline safety in order to recognize and mitigate risk, maintain safe and effective practices, and reduce accidents and near misses. Firefighters who receive initial fire training (S-130/190) are not required to take RT-130 in the same calendar year. RT-130 should be taken each calendar year after.	This course is designed to provide students with the knowledge and skills to perform the duties of the Basic Faller (FAL3) position, as described in the NWCG Standards for Wildland Fire Chainsaw Operations, PMS-212. The Instructor-led training will provide opportunities to apply this knowledge to real-world scenarios and practical exercises. Field exercises support entry level training for firefighters with little or no previous experience in operating a chainsaw, providing hands-on cutting experience in surroundings similar to fireline situations.
Prerequisites S-130/190 Fee: \$100	Prerequisite(s): S-112 Introduction to Chainsaw Operations (Online Component) 2025 Fee: \$350
S-130/190	S-236
Firefighting Training/Intro to Wildland Fire Behavior (Field Days Only)	Heavy Equipment Boss (Single Resource)
This course is for individuals who have taken S-130/190 online. Students must submit proof upon arrival to the academy that they have completed the online portion of this class. Please visit the Wildland Fire Learning Portal at wildlandfirelearningportal.net/ to complete the online requirements for S-130, S-190, and L-180 (On Demand Self-Enroll Courses).	This is a skill course designed to meet the training needs of a Heavy Equipment Boss, Single Resource (HEQB) on an incident as outlined in the NIMS: Wildland Fire Qualification System Guide, PMS 310-1, and the position task book developed for the position. Primary considerations are tactical use and safety precautions required to establish and maintain an effective dozer operation. A field exercise is required as part of the course.
Prerequisite(s): S-130/190, L-180 Online course Fee: \$200	Prerequisite(s): Qualified as Firefighter Type 1 (FFT1). Satisfactory completion of pre-course work. Fee: \$200

Field Observer	
Course provides skills necessary to perform as a field observer (FOBS) and/or a fire effects monitor (FEMO). Topics include roles & responsibilities of the FOBS and FEMO; how to make observations & document those observations; how to produce hand drawn & GPS field maps; & how to navigate using a compass & GPS. Course is also suitable for emergency responders from emergency response agencies who need a basic familiarity with the skills taught in this class in order to respond to all-risk incidents.
