<u>Present:</u> Board members present were Mr. Deyermond (representing the Town of Southampton), Mr. Hanley (representing the Town of Riverhead), Mr. Pally (representing the State of New York) and Mr. Grecco (representing Suffolk County). Also in attendance were Ms. Roth, General Counsel to the Commission and Commission Staff members included Mr. Corwin, Ms. Trezza, Mr. Milazzo, Ms. Jakobsen and Mr. Rizzo. Additional attendees are shown on the attached sign-in sheet.

The meeting was chaired by Mr. Grecco and called to order at 8:10 a.m.

1. Administrative

• Public Comment Period

Summary: Allan Grecco, representing Suffolk County, effective at the close of this meeting, will resign his position as Vice Chairman of the Pine Barrens Credit Clearinghouse Board of Advisors. He will resign because he has become the Director of Real Estate for Suffolk County and feels that this would be in conflict with his duties on the Clearinghouse Board. He stated he enjoyed working on the board and hopes that the Board will continue to keep up the level of good work that they have achieved in the past with maintaining the five million dollar balance and still conducting business transactions. At this point he introduced Andy Freleng from Suffolk County Planning as his successor on the Board. Mr. Freleng was a member of the Board previously as a representative for the Town of Southampton.

Mr. Grecco reviewed the numbers of Suffolk County's small lot acquisition program (see attached).

John Milazzo thanked Mr. Grecco for the outstanding job that he has done as Vice Chairman of the Clearinghouse Board of Advisors on behalf of Mr. Tripp who was not present at this meeting. Mitch Pally also extended his thanks to Mr. Grecco.

- Ratification of meeting summary from October 30, 1998

 Summary: It was suggested to hold the meeting summary over to the next meeting since Counsel has not read them.
- Ratification of meeting summary from September 9, 1998 (held over from last meeting)

 A motion was made by Mr. Pally and seconded by Mr. Devermond to adopt the
 meeting summary from September 9, 1998 as amended by Counsel. The motion was
 carried unanimously.
- County Treasurer's Report

Summary: Ms. Christina Cooke distributed the attached treasurer's reports for the months of October and November 1998. She stated that the ending balance for the month of October was \$5,143,412.33. There were no disbursements this month and the only activity was the interest accrued. In the month of September 1998 the ending balance was\$5,178,084.38. There were no disbursements this month and the only activity was the interest accrued. The anticipated disbursements for the months of January 1999 and February 1999 are approximately \$3,000.00. At this point Ms. Cooke asked for guidance from the Board members on the CDs maturing in January and February 1999. A brief discussion ensued.

A motion was made by Mr. Pally and seconded by Mr. Hanley to roll over the CDs maturing in January and February 1999 and to add \$200,000.00 from the municash account to an existing CD that is being rolled over. The motion was carried unanimously.

2. Pine Barrens Credit Applications

• Pine Barrens Credit Application of Carl Wenner; SC Tax Map # 200-456-1-2
Summary: Mr. Rizzo gave an overview of this application for the Board members. He stated that the applicant currently has a small structure (shed) on the property and needs the Board's guidance on whether or not the PBC allocation to the parcel should be reduced by one PBC. After a detailed discussion it was decided that if structure is not being used as a residence and that there is no associated sewage flow the allocation should not be adjusted. The staff was instructed to do a site inspection to confirm this understanding. If there was no associated sewage flow with the structure, staff was instructed to issue a LOI.

A motion was made by Mr. Grecco and seconded by Mr. Pally to give the full allocation on the Wenner credit application if there is no sewage flow associated with the structure on the site. The motion was carried unanimously.

3. Program Implementation

• Reverse Auction - Implementation

Summary: Mr. Milazzo stated that interested potential purchasers have been contacted and had to respond to the Clearinghouse staff by December 7, 1998 if they would like to participate in the reverse auction. He stated that four potential purchasers contacted the Clearinghouse by the deadline. Proposed agreements between the Clearinghouse and the purchasers were then mailed. Two of the potential purchasers executed the agreements and returned them to the Clearinghouse. The purchasers are seeking 29.00 PBCs in total. The price range for credits would be between \$15,000 and \$25,000. The closing date for a potential seller to participate in the reverse auction is March 15, 1999. All record landowners of Brookhaven sending area property would be invited to participate. It is anticipated that the actual purchases should take place in April or May.

A motion was made by Mr. Deyermond and seconded by Mr. Pally to accept the agreements from Campo Brothers and Robert Toussie to participate in the reverse auction. The motion was carried unanimously.

• Strategy for offering Clearinghouse Riverhead PBC's for sale

Summary: Mr. Milazzo explained that a letter (attached) was received from Fred Terry
who is looking to open a restaurant in Riverhead and needs to purchase up to three
PBC's to meet health department requirements. It was stated that he is willing to spend
up to \$10,000 per credit. A discussion ensued on what the credits that the Clearinghouse
owns in Riverhead should be sold for. After a lengthy discussion it was decided that the
credits should be sold for \$10,000 per credit.

A motion was made by Mr. Devermond and seconded by Mr. Hanley to offer to sell up to three PBC's for \$10,000 each without further resolution from this Board. The motion was carried unanimously.

Public Comment

Summary: Walter Olsen, CPR, feels that the Clearinghouse has failed and not succeeded as Mr. Grecco stated earlier because they have not spent the \$5 million that they originally started with. He also stated that the lack of success was due to the purchase price of PBCs not being fair market value. He mentioned that property in a subdivision in Southampton is going for \$115,000 per acre. That makes fair market value somewhere between the \$115,000 the developer is charging and \$5,000 that the County is offering.

At this point Allan Grecco pointed out that this is a voluntary program. The

Clearinghouse is doing what the Commission and the Act requested.

Dominic Nicolazzi, private developer, stated that he feels that the program has a way to go but that it will succeed in the future. He also stated that most of the landowners that he has dealt with have sold their credits to him because they were unhappy with the Pine Barrens situation and wanted out.

Bill Spitz, NYS DEC, stated that the PBC program created an opportunity for the landowners.





This letter is to inform you that I am hereby appointing Mr. Andrew Freleng to replace Mr. Allan Grecco as the County's representative to the Clearinghouse. As you may be aware, Mr. Grecco has recently assumed new duties as the Director of the County's Real Estate Division.

I would be remiss if I did not note the outstanding contributions of Mr. Grecco to the Clearing house. I think we would all agree that he has been responsible in large measure for the successful startup of the development rights credit program at the clearinghouse, doing much of the actual administrative work involved in getting the program up and running. I thin you would agree that in light of the recent Greenways bond approval, the extension of the Drinking Water Protection Program, and our aggressive acquisition policies, we need to concentrate on

<u>Present</u>: Board members present were Mr. Tripp (representing the Town of Brookhaven), Mr. Deyermond (representing the Town of Southampton), Mr. Pally (representing the State of New York) and Mr. Freleng (representing Suffolk County). Also in attendance were Ms. Roth, General Counsel to the Commission and Commission Staff members included Mr. Corwin, Ms. Trezza, Mr. Milazzo, Ms. Jakobsen, Ms. Plunkett and Mr. Rizzo. Additional attendees are shown on the attached sign-in sheet.

The meeting was chaired by Mr. Tripp and called to order at 10:10 a.m.

1. Administrative

• Public Comment Period

Summary: There were no public comments at this time.

• Resignation of Jack Hanley

Summary: Mr. Milazzo informed the Board members that Jack Hanley, who represents the Town of Riverhead, will be resigning from his position on the Clearinghouse Board. The reason for his resignation is due to illness. Mr. Milazzo also stated that the Town of Riverhead has been made aware of the situation and will have to appoint another Board member.

- Ratification of meeting summary from October 30, 1998 and January 15, 1999
 Summary: A motion was made by Mr. Pally and seconded by Mr. Freleng to adopt the meeting summary from October 30, 1998 as written and the meeting summary from January 15, 1999 as amended by Counsel. The motion was carried unanimously.
- County Treasurer's Report

Summary: Ms. Christina Cooke distributed the attached treasurer's report for the month of December 1998. She stated that the ending balance for the month of December was \$5,234,041.84. There was a \$6,000.00 disbursement to Connie Falkenstein this month for credits purchased by the Clearinghouse. Ms. Cooke stated that she would have

financial reports for the first quarter at the next meeting.

• <u>Authorization to allow any member to sign Clearinghouse documents</u>

Summary: Mr. Milazzo asked the Board to give permission for all Board members to sign Clearinghouse documents. After a brief discussion it was decided that the entire Board would be authorized to sign Pine Barrens Credit Certificates and that all other documents that require signatures would be signed by the Chair and Vice Chair.

A motion was made by Mr. Tripp seconded by Mr. Deyermond to authorize all Clearinghouse members to be able to sign Pine Barrens Credit Certificates as needed. The motion was carried unanimously.

• Ratification of sale of 1.80 PBCs to Baiting Hollow Commons

Summary: Mr. Milazzo asked the Board to pass a resolution ratifying the sale of 1.80

PBCs to Baiting Hollow Commons and the documents prepared to effect said sale.

A motion was made by Mr. Pally seconded by Mr. Freleng to ratify the documents prepared and executed to effect the sale of 1.80 PBCs to Baiting Hollow Commons for \$10,000.00 each totaling \$18,000.00. The motion was carried unanimously.

2. Pine Barrens Credit Applications

• Letter of Interpretation Application of Long Island Country Club SCTM # 200-594-2-4
Summary: Mr. Rizzo gave an overview of this application for the Board members
displaying a survey and ariel photographs of the site. He stated that there are several
sheds and a home with a pool on a 122+/- acre site. The site is presently a licensed
shooting preserve in the Town of Brookhaven's A Residence 1 zoning district. The site
previously was used as a golf course. Jack Sellek, the caretaker for the property attended
the meeting and offered to answer any questions that the Board may have pertaining to
the property. In response to a question from the Board, Mr. Sellek stated that the sheds
were used for feed storage. One shed is used as a meeting place for hunters.

The Board discussed the allocation of PBCs for the parcel. Prior to the meeting, Mr. Rizzo discussed with Mr. Sellek the process of applying for PBCs and the requirement that a conservation easement be placed on the parcel. Mr. Rizzo supplied a copy of the pre-approved easement for Mr. Sellek review. Mr. Sellek stated that the Club would want to reserve the right to rebuild the sheds if they are destroyed by weather or fire and to be able to maintain the field and walking paths as needed.

After a brief discussion by the Board, it was decided that only one credit would be

subtracted from their allocation for the home and that nothing else would be subtracted for the sheds since there is no sewage flow associated with them

A motion was made by Mr. Pally and seconded by Mr. Freleng to approve the allocation of 96.68 PBCs to the Long Island Country Club. Pursuant to the Plan, one PBC was subtracted from the allocation for the home on site. The motion was carried unanimously.

• <u>Correspondence from Alberta Emanuel</u>

Summary: Mr. Milazzo distributed the attached correspondence received from Alberta Emanuel to the Board members. He stated that he was seeking guidance from the Board on how to handle the correspondence received. After the Board reviewed the letter they decided to have staff send an LOI to the property owner describing her options with the program.

Roslyn Rifle Club Easement

Summary: Mr. Tripp signed the Pine Barrens Credit Certificate for the Roslyn Rifle Club in the amount of 4.43 PBCs generated from SCTM #200-299-2-17, 18, and 19.

3. Program Implementation

Status of Brookhaven Reverse Auction

Summary: The LI Country Club by letter dated March 12, 1999 contacted the Clearinghouse prior to the March 15, 1999 transmittal form deadline asking for an extension to for submitting a transmittal form. At the time of the letter, the Club did not know the number of PBCs to be allocated to the parcel, a determination that required Board guidance. The Board discussed with Mr. Sellek the amount of time necessary for the Club members to decide if they would participate in the reverse auction. After a brief discussion it was decided that it would be in the best interest of the purchasers to extend the offer if the purchasers give their permission to the extension.

A motion was made by Mr. Freleng and seconded by Mr. Deyermond to extend the Brookhaven solicitation offer for 30 days after first obtaining the permission of the purchasers in order to allow LI Country Club to determine if they would participate in the offer. The motion was carried unanimously.

Offer to purchase Riverhead PBCs

Summary: A letter was distributed to the Board members from Richard Israel. In the letter he states that he is in need of PBCs for two buildings in Riverhead that he is converting to medical uses. Mr. Israel was in attendance at the meeting and made a brief presentation on his proposal. The Board decided to authorize the sale of up to five PBCs

at \$10,000.00 per credit without further resolution of the Board. This offer is open until the next Clearinghouse meeting.

A motion was made by Mr. Pally and seconded by Mr. Freleng to authorize the sale of up to five PBCs at \$10,000.00 per PBC from the Clearinghouse. The offer will remain open until the next Clearinghouse meeting. The motion was carried unanimously.

Next Meeting

Summary: The next meeting of the Pine Barrens Credit Clearinghouse Board of Advisors will be held on April 30, 1999 at the Commission Office in Great River at 10:00 am.
