- e. Brookhaven Town Planning Board Referrals:
 - i. Granny Road Manor / south side of Granny Road, east of Mill Road, west of Richard Drive, Medford / 200-545-2-139.1 / Development including a change of zone from A Residence 1 to Planned Retirement Community to build 54 units apartment complex with recreational amenities and a sewage treatment plant on 9.18 acres.
 - Summary: The motion was made by Ms. DiBrita and seconded by Ms. Juengst to approve sending the draft response for Granny Road Manor/south side of Granny Road. The motion was approved by 4:0 vote.
 - ii. Vineyards at Coram / Middle Country Road, Coram / 200-475-2-1.2 and 200-475-1-12.4 / change of zone from J2 Business to Planned Retirement Community and development of a 74-unit Planned Retirement Complex on 12.43 acres. Summary: Ms. Hargrave discussed that the project details have changed since presented several months ago including the project site, the number of units, it will be connected to a sewer that already exist and they will purchase Pine Barrens Credits for the project. Ms. DiBrita asked which sewer and what is the proposed capacity availability. Ms. Juengst stated that the applicant should come forward with all the information they know including checking with the Health Department with the capacity availability.

The motion was made by Ms. DiBrita and seconded by Ms. Moore to approve sending the draft response for Vineyards at Coram/Middle Country Road. The motion was approved by 4:0 vote.

f. Venezia Square at Wading River CGA Development of Regional Significance / NYS Route 25A, Wading River / 600-73-1-1.004 and 1.16, 1.17, 1.18 and 1.19 / development of 37,000 square feet of commercial uses on 6.34 acres in the Business CR zoning district Summary: The motion was made by Ms. Moore and seconded by Mr. Charters to approve the extension deadline to 10/16/24. The motion was approved by 4:0 vote.
