LETTER OF NO PERMIT NECESSARY - ENDANGERED SPECIES ACT

The New York State Department of Environmental Conservation (DEC) has determined that:

Your proposed project to conduct tree removal/clearing activities is located within 1.5 miles of documented summer occurrence of the Northern Long Eared Bat (NLEB) (*Myotis septentrionalis*), a species listed as "threatened" by both New York State and the US Fish & Wildlife Service.

Tree cutting at this location between March 1 and November 30 could result in the "take" of this threatened species or their habitat within the meaning of Environmental Conservation Law (ECL) §11-535. The term "take" is defined in part as the direct killing or injury of individual members of a protected species, interference with critical breeding, foraging, migratory or other essential behaviors, or the adverse modification of the species' habitat. The "take" of a species listed as threatened is prohibited in the absence of a permit from this Department issued pursuant to ECL §11-535.

Based on the plans provided by P.W. Grosser, dated 8/29/2022, the DEC does not anticipate your proposed action to result in a take of Northern Long Eared Bat (NLEB) (*Myotis septentrionalis*). Therefore, no permit is required at this time pursuant to the implementing regulations (6NYCRR Part 182) of the New York State Endangered Species Act (Article 11-0535) if the following guidelines are met.

As labeled on the above referenced site plans -

GWA - No concern

GWB - No concern

GWD - Minimize disturbance along route to well. Avoid removal of large diameter trees. Limb trees for access when possible. Only chip cut trees between December 1st and February 28th.

GWE - Minimize disturbance along route to well. Avoid removal of large diameter trees. Limb trees for access when possible. Only chip cut trees between December 1st and February 28th.

GWG - Minimize disturbance along route to well. Avoid removal of large diameter trees. Limb trees for access when possible. Only chip cut trees between December 1st and February 28th.

GWH - No concern

BW1 - Minimize disturbance along route to well. Avoid removal of large diameter trees. Limb trees for access when possible. Only chip cut trees between December 1st and February 28th.

BW2 - Minimize disturbance along route to well. Avoid removal of large diameter trees. Limb trees for access when possible. Only chip cut trees between December 1st and February 28th.

BW3 – Minimize disturbance along route to well. Avoid removal of large diameter trees. Limb trees for access when possible. Only chip cut trees between December 1st and February 28th.
