
Dear Ms. Judith Jakobsen,

I am writing to you to beg you not to allow any development on the Pine Barrens.


It is critical to protect our Pine Barrens and our aquifer. Any development in the Pine Barrens region should not be a consideration, as these areas must be protected and remain sacred.



Dear Ms. Jakobsen,

We went to the first meeting, then called The Hills PDD, on April 26, 2015. We walked away horrified. The numbers that the Discovery Land Developers were throwing out were staggering: 591 total acres, 56 homes, 35,000 sq ft clubhouse, restaurant, olympic sized swimming pool, hotel facilities, cabins and 18 hole golf course.

Now some of those numbers have increased 3 fold, especially the amount of mansion sized homes, to 112 at last count. More importantly, now the project has been renamed the Lewis Road PRD. This is a completely different zoning proposal. This should not be approved as a modification but must be re-submitted as a new application.

This is largest last open space in all of Eastern Long Island. Please consider what will be lost, forever; open space. The chief characteristic that has kept Long Island green and clean.
