The Riverhead Planning Department has classified the above referenced project as a Type I action pursuant to 6 NYCRR Part 617.4 & Chapter 225 of the Riverhead Town Code. The Riverhead Planning Board is requesting Lead Agency Status for the purpose of SEQRA review.

Project Description: The above referenced application proposes a commercial center with the following intended uses and building areas: 27,000 sq. ft of retail within two (2) 10,000 sq. ft. buildings and one (1) 7,000 sq. ft. building; One (1) 4,000 sq. ft. bank with drive-through; One (1) 6,000 sq. ft building containing (1) 3,000 sq. ft. 76 seat restaurant and two (2) 1,500 sq. ft. take-out restaurants with 16 seats each. The project site is a 6.342-acre parcel located at 6435 NY-25A, on the south side of NY-25A approximately 789.64 feet west of the NY-25A / Wading River Manor Road intersection and is located within the Business CR (Rural Neighborhood Business) Zoning Use district more particularly identified as SCTM Nos. 600-73-1-1.4; 1.16; 1.17; 1.18 & 1.19.

Your agency has been identified as an involved or potentially involved agency. Pursuant to 617.6, a Lead Agency must be designated and agreed upon within 30 days from the date of your receipt of this notification. Please return the attached form to our office, indicating whether or not your agency wishes to assume lead agency status relative to this action.
