WHEREAS, by letter dated June 26, 2025, the Applicant, Marcos Ribeiro, submitted a request for a Compatible Growth Area (CGA) Hardship Application (Application) for development activity in the CGA. The application included a letter, Environmental Assessment Form (EAF) Part I, petition addressing the hardship criteria for the Project and Site Plan prepared by Professional Design dated May 25, 2025 and Survey prepared by Aerial Land Surveying, DPC dated January 28, 2025, and

WHEREAS, the Project is the development of a five acre Project Site with 96,000 square feet of greenhouse structures, grading, parking, retaining walls, concrete pad for a dumpster and other infrastructure for an agricultural land use located in the A Residence 2 zoning district (the Project or Proposed Action); and

WHEREAS, the location of the Project is on the west side of Weeks Avenue; Douglas Lane and Victoria Lane are opposite the site in Manorville in the CGA in the Town of Brookhaven, Suffolk County Tax Map Number 200-589-1-2 (the Project Site); and

WHEREAS, the Project constitutes development activity as defined in Environmental Conservation Law Article 57, the Long Island Pine Barrens Protection Act of 1993; and

WHEREAS, the Project is classified as a Type I Action pursuant to 6 NYCRR Part 617.6 of the State Environmental Quality Review Act (SEQRA), and

WHEREAS, at the regular meeting of the Commission on July 16, 2025, the Commission commenced SEQRA and performed a coordinated review with other Involved Agencies for Lead Agency status for the Project, and the Commission scheduled a public hearing on the Application for September 17, 2025; and
