**Resolution on the Core Preservation Area Hardship
Application of Town of Brookhaven**

Property located north of State Route 25, west of William Floyd Parkway, Ridge, Town of Brookhaven
SCTM # 200-296-1-1.2

Whereas, on June 12, 2002 the Town of Brookhaven filed with the Commission a request for a Core Preservation Area hardship exemption, which was later modified on July 10, 2002, to construct a 50'x90' museum building, gazebo, installation of 30-40 crushed-stone camping pads, shower/lavatory facility with above ground storage tank, and 50 car parking lot with access road, on Firemen's Museum and training area portion of the a 300.1 acre parcel situated of the Town's Firemen's Park; and

Whereas, a public hearing on the application was held by the Commission on June 12, 2002 and a transcript was thereafter made available to the Commission; and

Whereas, pursuant to the New York State Environmental Quality Review Act and regulations promulgated thereunder ("SEQRA"), the Commission conducted an coordinated review of the application as a Type 1 action; and

Whereas, the Commission has considered all materials submitted in connection with the application ,which included: 2001 aerial photo of firemen's training area and a 6/17/02 site plan of the Firemen's Museum area; and

Whereas, the Town of Brookhaven has agreed to not clear any more vegetation at the entire 300 acre Firemen's Park, which includes the Long Island Shooting Range facility; now therefore be it

Resolved, that the Commission hereby determines that the proposed action will not have a significant impact on the environment pursuant to SEQRA and the Commission has issued a negative declaration for this action; and, be it further

Resolved, that the Commission hereby determines that the application and accompanying information, as submitted, does meet the criteria for a Core Preservation Area hardship exemption pursuant to New York State Environmental Conservation Law Article 57-0121 (10); and be it further

Resolved, that the application for a Core Preservation Area hardship exemption is hereby approved with acceptance and incorporation into this resolution of the Town's stipulation that there will be no further clearing or development at the Town's Firemen's Park property; and be it further

Resolved, that this approval shall constitute the minimum relief to be accorded to the Firemen's Park property.
